

## **#RYCSTRIDETRIBE AMBASSADOR COMPETITION**

### **PARTICIPATION TERMS AND CONDITIONS**

These Terms and Conditions are to govern Participants of the #RYCStrideTribe Ambassador Competition (the "Competition").

#### **Competition Period**

2 June to 14 July 2021

**By participating in the #RYCStrideTribe Ambassador Competition You agree that You are bound by these Terms and Conditions.**

#### **1. RISKS ASSOCIATED WITH THE EVENT**

- 1.1 You accept that Your participation in the Competition is at your own risk and You acknowledge that the Competition organiser cannot manage all potential risks, including potentially foreseeable ones. You are obliged to strictly adhere to all applicable rules, directives, and instructions of the organiser in respect of the Competition.

#### **2. LIMITATION OF LIABILITY AND INDEMNITY**

In case you do already work with another brand, please disclose this information in your application. As a #RYCStrideTribe Ambassador you will receive PUMA kit. You will be representing the RYC Series, so we require that you do not wear or publicly show direct competitor brands to PUMA.
- 5.8 If you have won any prize over R 2 000 in any of the RYC Series Events or Activations over the last 12 months, you will not be eligible to be chosen as a RYC Series Ambassador.
- 5.9 By entering the Competition, you grant us the right to use your personal information to send you information about RYC Series and its related activities and activations.
- 5.10 Shortlisted finalists' will be that which have met the entry criteria, and which most closely meets the Entrant Participation and Competition criteria.
